During a period as Internal Consultant at Telia Denmark, 3 in Scandinavia as **Roaming Manager**, I established <u>International Roaming</u> and also participated in the negotiating team when the first agreement concerning <u>National Roaming</u> on commercial grounds was reached in Denmark. The same was repeated while at 3 negotiating National Roaming for Sweden and Denmark, so I have negotiated three National Roaming agreements and hundreds international roaming agreements.
